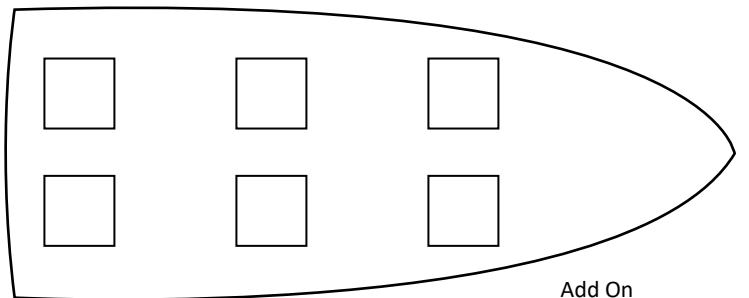

INBOARD GAS/DIESEL ENGINES & STERNDRIVES:

- Run, flush and fill engine(s) with non-toxic antifreeze
- Fog carbureted engines and run fuel injected models on remote tank with winter fuel mixture
- Change engine oil and oil filter
- Check engine coolant levels
- Change Spin-on water separating fuel filter and/or Racor filters and stabilize fuel in tank
- Change sterndrive gear oil and lube accessible grease points
- Remove sterndrive propeller, grease propeller shaft and re-install
- Inspect propeller and running gear for visible damage
- Inspect engine for signs of damage, leaks or component fatigue
